# OCCUPATIONAL HEALTH FIELD EXPLORATORY MEETING TO RE-REGISTER AS THE OCCUPATIONAL HEALTH AND SAFETY CRG DISCUSSION POINTS

# **TUESDAY 13<sup>th</sup> OCTOBER, 07.30 – 08.30**

These discussion points were taken from the first Occupational and Health and Safety Group (OHSG) at the 17<sup>th</sup> Cochrane Colloquium in Singapore, October 11-14, 2009 by Jason Wasiak (J.Wasiak@alfred.org.au)

Following a presentation from Dr Jos Verbeek (JV) (see below) detailing the history, scope, achievements of the Occupational Health Field, the following comments were raised as discussion about the Field's re-registration to a Cochrane Review Group (CRG).

#### Registration and management of titles:

JV suggested that collaborative links already exist with a number of CRGs (Back, Injuries and Bone Joint and Muscle Trauma) and potential overlap and registration of new titles should not be problematic. If anything, it would benefit CRGs if there was a new CRG which covered this topic area. Moreover, there would be refinement and ongoing development of the proposed OHS CRG scope in order to manage any potential concerns.

#### **Funding arrangements:**

The Finnish Institute of Occupational Health has already committed to funding the proposed CRG at €150,000 per year.

#### **Mentoring:**

The Injuries Group had offered to mentor the new CRG.

## Monitoring and Registration Group (MRG) requirements:

JV detailed that the proposed OHS CRG would fulfil the monitoring and registration requirements as they had an advisory and editorial board, a consumer representative, methodological/statistical support, associated support and involvement from Cochrane Centres (Dutch Cochrane Centre, Nordic Cochrane Centre), CRGs (Injuries, EPOC, Back, Bone Joint and Muscle Trauma) and Fields (Primary Health, Child Health), appropriate staffing, a specialised registry, author support and peer review processes.

#### **Cochrane Occupational Health Field**

- o Finnish Institute of Occupational Health (FIOH) started Occupational Health Field in Cochrane Collaboration
- o funding from FIOH, Finnish Ministry of Health, FinOHTA, Dutch Ministry of Social Affairs, NIOSH Australia
- o officially registered with CC in May 2004
- o integrated in Knowledge Transfer Team since 2006
  - o Jani Ruotsalainen, Marika Lehtola, Leena Isotalo, Irja Laamanen, Jos Verbeek, Juha Liira, Riitta Sauni et al.
- o Cochrane Occupational Health Field (COHF)
- o mission: to provide up to date evidence on the effects of occupational health interventions
- o www.cohf.fi

# **Scope of Occupational Health Field**

- o Occupational health interventions
  - o strategies or activities aimed at influencing
  - o exposure to health hazards at work
  - o worker behaviour that is unfavourable to health
  - o occupational or work-related diseases, injuries or disorders
  - o occupational disability and avoidable sickness absence
  - o skills of occupational health professionals
  - o general health behaviour when measured at the workplace
- o Evidence of effectiveness

- o all trials with a comparison group
- o time-series

# Tasks of the Occupational Health Field

- To stimulate the conducting of Cochrane Occupational Health Reviews
- To maintain and develop a database of occupational health intervention studies
  - o regular submissions to central
- To provide information about occupational health and safety evidence via:
  - o website: www.cohf.fi
  - o newsletter
  - o courses
  - o journal articles

#### **Achievements of COHF**

- Almost doubled the number of review titles on occupational health outcomes in the Cochrane Library (www.thecochranelibrary.org)
  - o also published in major journals
    - (BMJ, AJPM, SJWEH)
  - o noise review featured review of the week (podcast)
  - o Cancer survivors and employment (JAMA 2009)
- Development of review methodology
  - o inclusion of randomised controlled trials, non-randomised controlled before-after studies and interrupted time series
- Still increasing global network of review authors and stakeholders
  - o both experts (NIOSH, FIOH) and practitioners involved
  - o funding from Finland, Australia, the Netherlands
- Database with > 1400 occupational health intervention studies
  - o www.cohf.fi
- Search strategy for Medline:
  - o how to best locate OH intervention studies in Medline (OEM 2005)
- Training material and courses

## In the Cochrane Library

- Full Systematic Reviews on occupational health (N=41)
- Reviews published before/outside COHF (N=28)
  - Smoking cessation, Screening for lung cancer, Vocational rehabilitation for schizophrenia, Back pain and return to work
- New Reviews published with COHF involvement (N=13)
  - Hearing protection, Stress management, Prevention of injuries in Construction and Agriculture, Return to work in Depressed Workers, Voice disorders, Noise-induced hearing loss, Alcohol testing
- Registered Protocols with COHF involvement (N=9)
  - Pre-employment examinations, Sharps injuries, Cancer Survivors and return to work
- Registered Titles with COHF involvement (N=4)
  - o Shift work, Sickness absence, Chemical exposure

#### Why change status to Review Group?

- Field involved in review production
  - o difficult to show involvement
  - o first author has all the power
- Specialist reviews
  - o complex interventions
  - o non-randomised studies
  - o special workplace setting
- Communication with many CRGs
  - o slightly to very different rules and procedures

- o difficult to bring in expertise in all groups
- o varying level of OSH expertise in CRGs

### **OSH Review Group: scope**

- Including all interventions aimed at
  - o preventing or treating
  - o occupational (work-related) diseases,
  - o disability (sickness absence)
  - o and injuries
- Excluding
  - general health promotion carried out at the workplace
  - lifestyle, cardiovascular risk factors
  - primary health care carried out at the workplace
  - In case of overlap priority to
    - o workplace based interventions
    - o preventive interventions

  - o coordinating editor (0,2 FTE)
  - o managing editor (0,7 FTE)
  - o trials search coordinator (0,5 FTE)

- communication with members
  - o website (www.cohf.fi)
  - o newsletter (>500 subscribers)
